- 4. The representation document may be received up to the beginning of the Shareholder's General Meeting.
- 5. The presence at the General Meeting of a Shareholder who has sent a representation letter will be considered as revoking his/her attribution of representation powers.
- 6. The present minute of representation letter does not constitute a request for representation, having the sole purpose of informing shareholders about the General Meeting and of the possibility of nominating a representative.
