ANNOUNCEMENT

Sonae Capital hereby informs, under the terms of paragraph 8 of article 14 of CMVM Regulation no. 05/2008 and article 248B of the Portuguese Securities Code, on behalf of its persons discharging managerial responsibilites ("Dirigentes") and of the persons discharging managerial responsibilites ("Dirigentes") of its controlling company Efanor Investimentos, SGPS SA that, on 27 March 2012, Pareuro BV, purchased from Sonae – SGPS, SA, over the counter, 16,600,000 shares representing 6.64% of the share capital and the voting rights of this Company for the price of 0.215 Euros per share, equivalent to the average market closing price of the share on the Euronext Lisbon regulated market over the 30-day period prior to the transaction.

This notice is due to the fact that there are directors of Sonae Capital, SGPS, SA who are also directors of Sonae - SGPS, SA and of Efanor Investimentos, SGPS, SA and that the companies involved in this transaction are directly and indirectly controlled by Mr. Belmiro de Azevedo, Chairman of the Board of Directors of Sonae Capital, SGPS, SA, Sonae – SGPS, SA and Efanor Investimentos, SGPS, SA.

It is moreover hereby informed that under the applicable legal terms of article 20 of the Portuguese Securities Code this qualified shareholding is attributable to Mr. Engenheiro Belmiro de Azevedo, as follows:
