Sonae Capital, SGPS, S.A. (Sonae Capital) hereby informs, as required by Article 14, paragraph 5, of the Regulation No. 5/2008 of the Portuguese Securities Market Commission (CMVM), that its Director, Ivone Maria Pinho Teixeira da Silva, has informed today, pursuant to the terms of Article 248-B of the Portuguese Securities Code and of Article 14, paragraph no. 1, of the Portuguese Securities Market Commission Regulation no. 05/2008, that on 29th March 2019, she has purchased 130,674 shares of Sonae Capital, under the Medium Term Incentive Plan of Sonae Capital. This transaction was completed over-the-counter at a reference price of € 0.875, Sonae Capital share market closing price on 29th March 2019.

As a result of this transaction, it shall be attributable to the aforementioned Director the voting rights pertaining to 408,269 shares, directly held.
